Paid competitors receive a full access pass to the weekend's events including the Friday evening cocktail party, Saturday evening film festival, Sunday seminars, door prizes (eligible to non-winning competitors), annual t-shirt, USB flash drive, and the Sunday awards ceremony. Guest passes are available for a fee for friends and family to join in the fun. Only competitors are eligible for door prizes. The Sunday Awards Ceremony is a free event open to the public.

#### **GENERAL RULES FOR ALL PARTICIPANTS:**

- 1. All participants must sign and submit a Waiver of Liability.
- 2. Participants may enter both video and photo competitions. Participants willing to shoot both video and photo competitions will be awarded for their multitasking with accumulated prize points.
- 3. Images must be taken within the Monterey Bay and Big Sur region during the competition. Diving from Point Lobos State Reserve is allowed, but divers must make a reservation two months in advance at http://www.pointlobos.org.
- 4. Split shots or over under images are allowed, but all photos must be composed to include at least 50% underwater.
- 5. Boat diving is allowed and we encourage you to support our local dive boats with your business.
- 6. We have adopted the conservation rules established by EPIC®\*\*. Marine life should never be stressed or endangered for the sake of a photo or video. Any Entrant and/or Dive Leader suspected of exhibiting the following behavior will be disqualified:
  - a. Diver(s) visibly damaging the environment (eg: dangling or dragging gear, kicking up sand);
  - b. Animals with signs of stress (eg: puffed puffers, inking octopus);
  - c. Animals moved to an unnatural environment or risky location;
  - d. Animals being fed;
  - e. Marine life being touched (eg: coral polyps, handling sea snakes);
  - f. Diver(s) exhibiting poor buoyancy control.
  - \*\* The judges will be asked to interpret this guideline and disqualify any images that are suspect to poor behavior.

- 7. All entries must be submitted within the posted hours and on the USB flash drive received at registration and use the file naming convention explained in the entry instructions. A cell phone or local number must be submitted in case there is a problem with the entries.
- 8. Each participant is responsible for his/her own safety and the proper operation of his/her diving and photographic equipment. NCUPS, Monterey Shootout, and Backscatter are exempt from all liability or responsibility whatsoever for all personal injury, property damage, or wrongful death, however caused, including but not limited to property liability or the negligence of the released parties whether passive or active. Each participant must use his/her own judgment regarding diving safety.
- Should conditions make diving unsafe or should a large number of participants decide not to dive due to conditions, NCUPS and the Monterey Shootout reserve the right to postpone and reschedule the competition to a future date within 12 months from its original date.
- 10. Competition judges and presenters are not eligible to compete in the Monterey Shootout for the year that they judge or present.
- 11. A current year competition judge's spouse or significant other and their immediate family members are not eligible to compete for the given year.

#### WHAT WE ASK FROM OUR COMPETITION JUDGES:

- 1. The judges volunteer their time as working professionals with an interest to help promote underwater arts.
- 2. The judges will award a first, second and third place in each subject for each category of participants. Honorable Mentions will be awarded at the judges' discretion. No "Best of" category or show will be awarded.
- 3. The judges have the authority to combine categories should there be too few entries in a single category. The judges will eliminate an image if they believe it might violate the conservation rules or does not fit the category. The judges will select images and video based on the question, "Would I display this as a print on my living room wall or want to share this video with my friends?"
- 4. The decision of the judges will be final in all cases.

### **OUR "SHARE THE WEALTH" PRIZE RULES:**

- 1. A weighted point system will be used for awarding prizes to encourage competition and reward excellence. Points are awarded for all places including honorable mentions. Photo and Video competition points are added together.
- 2. No participant may receive more than one prize.
- 3. Prize selection will occur immediately following the showing of the winning images based on highest points.
- 4. Each participant eligible to select a prize, whether through the competition or the door prize, must be present to select a prize unless they have designated a proxy in writing or by phone prior to the beginning of the awards ceremony. The proxy must be ready to select a prize within 5 minutes of the winner being announced. Any entitled participant who was not present during the prize selection and did not designate a proxy will have thirty days thereafter to select from any remaining prizes.
- 5. In the event of a tie, winners' prize selection order will be determine through random selection.
- 6. All persons selecting a prize agree that their image(s) or video may be used by NCUPS and the Monterey Shootout for promotion of the club and its competitions in future years.
- 7. NCUPS and the Monterey Shootout have solicited prizes from various individuals and companies. Each prize donor has represented to NCUPS and the Monterey Shootout that the prize offered will be provided to the participant who selects it. However, NCUPS and the Monterey Shootout do not guarantee that the donor will actually deliver the prize and will not be responsible if the donor does not do so.
- 8. Prize trips must be used within one (1) year and may have other restrictions.

9. Prizes are nontransferable.

#### PHOTO COMPETITION - ADVANCED SKILL LEVEL

If you have received a total of 4 or more prizes (first, second or third place wins) in a competition (excluding NCUPS minicomp) the advanced category is for you. Our prize point system will reward winners in this category with the highest points and thus the best prizes.

### **PHOTO CATEGORIES:**

Entrants can submit a maximum of 6 images to the competition.

#### Macro Traditional (enter up to 3 images):

Enter up to three of your best images that meet these criteria. Our "Traditional" categories allow for the adjustment of brightness, contrast, color, and sharpness when applied to the entire image ONLY. Cropping, cloning, masking, backscatter removal, and other digital manipulation is NOT allowed in this category. This restriction on digital manipulation will enable people who are not as savvy at Photoshop to compete on even ground as those with more experience. It also highlights better composition and lighting skills by not allowing cropping and cloning.

As a general guide we consider a macro image to be smaller than a real world size of 5" x 7". However, we embrace the new optical technologies that allow macro shooters to capture exciting images that break the barrier of wide-angle and macro. Thus, we will ask our judges to select all macro images by the question, "Does this image feel like a macro image?" We encourage creativity and will allow the judges to make the decision if your image "feels like macro."

#### Macro Unrestricted (enter up to 3 images):

Enter up to three of your best images that meet these criteria. Our "Unrestricted" categories have no rules regarding digital manipula¬tion; anything goes.... but please note, the judges usually find that less is more.

As a general guide we consider a macro image to be smaller than a real world size of 5" x 7". However, we embrace the new optical technologies that allow macro shooters to capture exciting images that break the barrier of wide-angle and macro. Thus, we will ask our judges to select all macro images by the question, "Does this image feel like a macro image?" We encourage creativity and will allow the judges to make the decision if your image "feels like macro."

#### Wide-Angle Traditional (enter up to 3 images):

Enter up to three of your best images that meet these criteria. Our "Traditional" categories allow for the adjustment of brightness, contrast, color, and sharpness when applied to the entire image ONLY. Cropping, cloning, masking, backscatter removal, and other digital manipulation is NOT allowed in this category. This restriction on digital manipulation will enable people who are not as savvy at Pho¬toshop to compete on more-or-less even ground as those with more experience. It also highlights better composition and lighting skills by not allowing cropping and cloning.

As a general rule, we consider any image of a real world size greater than 5" x 7" to be wide-angle, however the judges will be the final rule on what is considered to be wide-angle. We encourage creativity and will allow the judges to make the decision if your image "feels like wide-angle."

#### Wide-Angle Unrestricted (enter up to 3 images):

As a general rule, we consider any image of a real world size greater than 5" x 7" to be wide-angle; however the judges will be the final rule on what is considered to be wide-angle. We encourage creativity and will allow the judges to make the decision if your image "feels like wide-angle."

#### PHOTO ENTRY INSTRUCTIONS:

Participants must bring their own system for image viewing, selection, and manipulation.

Each photo category has rules that state the type of manipulation that is allowed.

Each participant may submit a maximum of six images to the competition on the USB flash drive received at registration.

You choose how to spread your selection of 6 total images across the categories.

Entrants should save their images on the flash drive as full resolution, 100% quality JPEGs with the following naming convention separated by underscores (\_):

- a. skill level (ADV for Advanced)
- category (MT for Macro Traditional, WT for Wide-angle Traditional, MU for Macro Unrestricted,
   WU for Wide-angle Unrestricted)
- c. Three digit Entrant number (found on your USB flash drive, please keep leading zeros in your file name)
- d. Number of pictures submitted in this category [i.e. 1, 2 or 3]. Remember a grand total of 6 entries are allowed for the competition, split your 6 entries across the available categories however you see fit.
- e. Entrant name (firstname lastname)
- f. .jpg

#### **Examples:**

Competitor John Doe, who is entrant number 010, in the Advanced skill level, would name his second picture in Macro Traditional:

#### ADV\_MT\_010\_2\_John\_Doe.JPG

Competitor Jane Doe, who is entrant number 105, in the Advanced skill level and is submitting her third picture in Wide-angle Unrestricted would name her entry:

ADV\_WU\_010\_3\_Jane\_Doe.JPG.



## **THE MONTEREY SHOOTOUT 2013**

Photographers may shoot in RAW and must be prepared to deliver their RAW image if asked to do so by the judges.

When saving to JPEG please include the metadata.

All entries must be submitted within the posted hours of the competition located in the schedule and on the USB flash drive received at registration.

A cell phone or local number must be submitted during registration in case there is a problem with your entries. Images submitted in the wrong category will be disqualified.

In-camera duplicates will be judged only in the first category the judges see them.

All entries must be submitted using the file naming conventions explained above along with a completed entry submission form. Entries must be submitted within the posted submission hours and on the USB flash drive received at registration. No late submissions will be accepted.



## **GENERAL RELEASE FROM LIABILITY**

In consideration of my participation in the Monterey Shootout presented by Northern California Underwater Photographic Society (NCUPS), I hereby fully release and discharge NCUPS, Backscatter Underwater Video and Photography and The Monterey Shootout, their officers, directors, members, course instructors, dive trip leaders, boat owners and skippers, drivers, agents, attorneys, and their heirs, successors and assigns (the "released parties"), from any present and future claims, actions and damages, of any kind and nature, including negligence, property damage, personal injury, or wrongful death, arising from my participation in the Monterey Shootout. This release includes, but is not limited to, all compensatory, non-economic, consequential, incidental, and punitive damages.

#### PLEASE READ AND INITIAL ON EACH LINE BELOW:

 I am aware that skin and SCUBA diving and underwater photography take place in unconfined waters such as oceans or lakes. Such waters are subject to current, waves, surge, cold, and wind and therefore can be hazardous activities. I am voluntarily participating in this activity with knowledge of the dangers involved and hereby agree to accept and assume any and all risks of property damage, personal injury, and death.
I understand that skin and SCUBA diving activities involve certain risks, including but not limited to, travel to and from the site of the activity, possible negligent or reckless conduct of other participants, serious injury or death resulting from drowning, near drowning, arterial air embolism, decompression sickness (DCS), collisions with boats, propellers, and vehicles, entanglement with kelp or fishing line, hypothermia, wave and surf-related injuries, and contact with dangerous marine life. I voluntarily assume and accept all of these risks.
 I understand that skin diving, SCUBA diving and underwater photography activities in which I participate may be conducted at sites that are remote from available medical assistance; and I accept the risk that medical assistance may not be readily available should I become injured.
 I understand and agree that if I choose to dive without a buddy or that if I leave my buddy, I assume all risks of injury or death resulting from that decision and hold the released parties harmless therefore.
 I agree to provide my own dive and camera equipment for this NCUPS activity and warrant and represent that such equipment is in good condition and adequately maintained according to manufacturer's recommendations, DOT regulations (for tanks), and generally accepted safe-diving practices. Underwater photography also includes substantial risk of property damage, including flooded cameras and strobes and other damage to camera and dive equipment.
 I represent that I am in good physical condition, that I have a valid and current certification from a generally recognized SCUBA diver certification agency; and that I follow safe diving practices at all times.
I understand and agree that I have not compensated the released parties for any services. I further acknowledge that any person providing services to me in a NCUPS sponsored event is an uncompensated volunteer. I understand and accept that the people providing such services are not doing so as professionals employed by the diving operator or owner or the judgment of any NCUPS member concerning water conditions, the appropriateness of SCUBA diving in such conditions or the
